

1. About payment of EMD & Tender Fee - All payments should be paid by Demand Draft and in favour of Indian Council for Cultural Relations, Kolkata.
2. About working hours - The requirement of light/sound technician is in accordance with the activities of the centre, e.g. if there are events from the morning till late evening, technicians must be there. Therefore, the attendance/bio-metric is mandatory.
3. About police verification - The verified photo Identity Card with all required details issued by the agency would be permitted.
4. About the Financial Bid - The monthly/yearly charges may be furnished excluding the GST.
